Bob Thurgarland stated that the County Prosecutor's office will be holding a discussion on April 26 from 7:00 to 8:30 P.M. at Del Val High School on the Heroin epidemic in Hunterdon County.

A recent random drug test of athletes at Del Val showed no positive results for drugs.

Jeff Waldron stated that heroin is very cheap and easy to get. Del Val is mostly marijuana use, while North Hunterdon and Hunterdon Central have very large heroin problems.
