

BOARD OF HEALTH
APRIL 12, 2018

On Thursday, April 12, at 7:40 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Tony Szumski, and the following statement was read at the commencement of the meeting.

Adequate notice of this regular meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 21, 2017, by:

1. Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.
2. Mailing the same to the Hunterdon County Democrat and the Express Times.

Members present at the meeting: Pearl Hammerstone, Tony Szumski, Donna Lizanich, Audrey Balogh, and Christopher Balogh

Also in attendance were resident Valerie Sivilli and Bill Jupinka, Bayer-Risse Engineering

Members Absent: Robert Thurgarland, Jeffrey Waldron and Vann Smith

Donna Lizanich made a motion, seconded by Audrey Balogh to accept the minutes of March 8, 2018. Motion carried.

The following correspondence was given to members present.

1. Memo to Pearl Hammerstone from Robert Vaccarella, REHS April 5, 2018
 Re: Septic System Alteration Waiver Request
 Block: 12 Lot 14 692 Riegelsville Road, Milford, NJ Valerie Sivilli, Applicant
 Distance of well on neighboring Lot 15 to proposed disposal field does not meet the 100 foot setback as required by code.

Mr. Jupinka explained the new system will replace the cesspool now in existence on the property. A certified letter has been sent to the neighbor, Lot 15, advising him of the septic alteration being less than 100 feet from his well. There is no information on the depth of the well. No response has been received from the neighbor since the certified letter was just sent out three days ago.

After discussion, Christopher Balogh made a motion to grant a conditional waiver, seconded by Audrey Balogh. A roll call vote was taken: Donna Lizanich aye, Pearl Hammerstone aye, Tony Szumski aye, Audrey Balogh aye and Christopher Balogh aye.

The conditional waiver for Block 12, Lot 14 would become valid upon the receipt of the stub from the certified Letter sent from Bayer-Risse to the neighbor advising him of the proposed disposal bed being less than 100 feet to his well. Once the receipt of the stub is received, or refusal of the certified mail, Bayer-Risse will send another certified letter to the neighbor stating an ultra violet system could be installed on his well as extra protection. If no response to either letter is received from the neighbor, within 30 days, stating he wants no one on his property or the ultra violet system on his well, this Waiver will be issued to Valerie Sivilli.


