BOARD OF HEALTH October 10, 2019

On Thursday, October 10, 2019, at 7:32 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Audrey Balogh and the following statement was read at the commencement of the meeting.

Adequate notice of this regular meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 13, 2018, by:

- 1. Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.
- 2. Mailing the same to the Hunterdon County Democrat and the Express Times.

Members present at the meeting: Pearl Hammerstone, Tony Szumski, Audrey Balogh, and Christopher Balogh Members Absent: Donna Lizanich, Lisa Mickey and Vann Smith Also in attendance was Kurt Hoffman of Kurt Hoffman Engineering

Christopher Balogh made a motion, seconded by Tony Szumski, to accept the minutes of September 12, 2019. Motion carried.

Septic System/malfunctioning Alteration Waiver Request – Block: 27 Lot: 6 75 Old River Road, Milford, NJ Kurt Hoffman requested a waiver, showed plans to correct a malfunctioning system with no expansion. The design is in full conformance with 7:9A except for the following.

A minimum of two soil logs required for each disposal field. Only one was performed on the property, due to rock formation.

The bottom of the seepage pits shall be a minimum of eight feet above any hydraulically restrictive horizon or substratum not fully penetrated or any massive rock substratum. The bottom of the proposed seepage pits is only 6 feet deep, again due to rock.

The proposed seepage pit is 140 feet from the existing geothermal well and not the minimum 150 foot setback requirement, but greater than 150 ft. from the potable well.

As per NJAC 7:9A-3.3(e)2ii the new system will be more in conformance with this chapter.

After discussion, Christopher Balogh made a motion to grant the waiver for Block 27, Lot 6 for Bob Rader, 75 Old River Road, Milford,NJ, for his Septic System Alteration as mentioned above. Tony Szumski seconded the motion. A roll call vote was taken. Tony Szumski, aye; Christopher Balogh, aye; Audrey Balogh, aye; Pearl Hammerstone, aye. It was a unanimous *aye* vote to grant this waiver.

Old Business:

Audrey reported on a dog bite we had last month. The woman that was bitten got an infection and spent time in the hospital. The dog that bit her had bitten a few times before, so the dog was euthanized.
