

BOARD OF HEALTH
September 10, 2020

Confinement required for ten days.

The above correspondence was discussed and action taken as necessary.

Cathy Miller sent an e-mail regarding the fall 2020 Holland Happening Newsletter. She is requesting information to be submitted in a word document to her by 4:00 P.M. October 2.
(Audrey Balogh stated she, and possibly Donna, would submit information from the Board of Health.)

Pearl had spoken to the Holland Township dog licensing official regarding animals who had bitten someone numerous times or considered to be vicious dogs. She has no information on this under her jurisdiction, she only licensed the animals.

Pearl had spoken to Carla Hobbs of the Hunterdon County Board of Health since our last meeting regarding Confidentiality of Animal Bite Records.
She stated, under HIPAA, the information cannot be shared publicly. Even though we get information on animal bite reports, and get a monthly report from St. Hubert's, our animal control officer. We cannot get a published report on the "release from confinement" with the owner's name, address and phone number.
The County gets this report, and if there is rabies involved, they notify our local police department.
(Carla was supposed to send me a copy of the procedure that is followed on these Bite Reports, but she has not sent it yet, even though I called her last week as a reminder.)

Audrey Balogh made a motion to adjourn the meeting, seconded by Donna lizanich. The meeting adjourned at 8:15 P.M.
