

BOARD OF HEALTH
December 10, 2020

On Thursday, December 10, 2020, at 7:41 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.
