

BOARD OF HEALTH
MAY 12, 2022

On Thursday, May 12, 2022, at 7:37 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, 61 Church Road.

Audrey has been keeping up with the Township and County Covid-19 cases and deaths since the pandemic started. Holland Township's numbers have been stable for the past few weeks. The number of cases have been going down. There have been one million tests done for Covid-19

May 11, 2022 Hunterdon County reported 22,807 cases testing positive, 216 deaths
Holland Township cases were 817, 7 deaths and 75 new cases
