

**BOARD OF HEALTH**  
**NOVEMBER 10, 2022**

On Thursday, November 10, 2022, at 7:34 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, 61 Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Audrey Balogh, and the following statement was read at the commencement of the meeting.

Pearl spoke to Carla Hobbs of the County Board of Health regarding same dogs biting people. She stated they send out the Bite Report after being notified by a medical facility. It is then up to the Animal Control Officer to put the dog in quarantine, usually ten days. It is up to the Animal Control Officer to determine if it is a vicious dog.

Pearl has to report back to Melissa, Deputy Clerk, regarding two expiring terms on the Board of Health at the end of December.

Vann Smith wants to stay on as an alternate for another two years.

Christopher Balogh wants to be reappointed for another four year term.

Donna Lizanich attended a class sponsored by the County Health Department. It was a Mental Health First Aid presentation, which was very informative.

Christopher Balogh made a motion to adjourn the meeting, seconded by Tony Szumski. The meeting adjourned at 8:05 P.M.
