

BOARD OF HEALTH
JANUARY 11, 2024

On Thursday, January 11, 2024, at 7:02 P.M., the reorganization meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, 61 Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

Secretary Pearl Hammerstone opened the reorganization meeting by reading the following statement.

Adequate notice of this reorganization meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 21, 2023, by:

1. Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.

She requested the upgraded plans be sent to the Holland Township Municipal Building, attention Pearl Hammerstone, Secretary of the Board of Health. As of today's date, nothing has been received.

Christopher Balogh will make the revisions to the **Septic Waiver Checklist**, so it can be forwarded to the Township Committee for approval.

The request from Melissa Tigar for the Holland Township's 150th Celebration committee will be addressed in the next few months. The names of the Board of Health Members and a mission statement can be submitted for the booklet.

Christopher Balogh made a motion to adjourn the meeting, seconded by Donna Lizanich. The meeting adjourned at 7:45 P.M.
