#### Meeting called to order at 7:00 PM

Adequate notice of this meeting was given pursuant to the open public meeting act, by the Twp. Clerk on December 21, 2017.

Minutes of the March 2018 meeting were approved.

#### **Books**

Kathy Sciarello printed both hardcover and softcover samples of her book "A Tour of Holland Township – As Seen and Told by Frank Stull -1995". This book will not be offered for sale, but ten copies will be ordered for limited distribution. Kathy also showed a proof of her new book "Early Life and Traditions of Holland Township – 1908-1915". Kathy will order 60 copies. A final book is planned that will cover Milford Leader articles from 1916 through 1923. Proceeds from the sale of books are deposited in the General Fund of Holland Township.

#### **Oral Histories**

Larry LaFevre spoke favorably about the interview with Mr. Sy Compton, and filed the oral history transcription. Most oral histories are not transcribed or filed. Larry said he plans to visit Mr. and Mrs. Hummer. He asked volunteers to assist with the interview of Mr. and Mrs. Wydner (date and time to be determined). Joe Becker suggested arranging an interview with Mrs. Marion Pursell of Mount Pleasant who has extensive knowledge of Little York and vicinity.

#### Signs / Plaques

Joe agreed to prepare a brief narrative for a plaque to be dedicated to Frank Stull. He recommended ordering the plaque from Palmer Trophies in Easton, PA. Larry spoke about the Clark / Robbins plaque, but placement is an issue as the property cannot be trespassed.

#### **Files**

Larry announced that the file room at the Riegel Ridge Community Center is ready for the Holland Township Historical Preservation Commission. The floor is refinished along with other improvements. Larry recommended that this storage space should be promptly claimed, and files should be moved there quickly. Also, Larry suggested creating an inventory of all items stored there.

#### **Other Business**

• Hunterdon County Community Day – June 2<sup>nd</sup> – Topic was discussed. However, there is limited interest in participating in the event.
