ORDINANCE 2017-8

AN ORDINANCE AMENDING AND SUPPLEMENTING SECTION 68-7 CONCERNING THE LICENSING OF KENNELS, PET SHOPS, SHELTERS AND POUNDS OF CODE OF THE TOWNSHIP OF HOLLAND

WHEREAS, N.J.A.C. 8:23A-1.1 *et seq*. sets forth certain sanitation and operational requirements for kennels, pet shops, animal shelters, and pounds; and

WHEREAS, the Township of Holland issues licenses for such facilities and requires inspections be conducted by the Hunterdon County Board of Health to ensure compliance with <u>N.J.A.C.</u> 8:23A-1.1 *et seq.*; and

WHEREAS, by memo dated April 12, 2017, the County Board of Health has requested that the Township review its licensing ordinance for compliance with <u>N.J.A.C.</u> 8:23A-1.1 *et seq.* and advises that it will be inspecting such facilities in June and July of each year;

WHEREAS, in order to ensure consistency with applicable law and the above-referenced memo, the Township Committee has determined that it is in the best interest of the Township to amend Section 68-7 of the Township's ordinances.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Holland, in the County of Hunterdon and State of New Jersey, that the following provisions of the Code of the Township of Holland are amended as follows:

SECTION 1. Section 68-7 of the Code of the Township of Holland entitled "Kennels and other establishments; application for license; fee; safe control required" is hereby amended and

supplemented as follows (Additions indicated in boldface and italics *thus*; deletions indicated with strike-through thus):

- A. Any person who keeps or operates or proposes to establish a kennel, pet shop, shelter or pound shall apply to the official of said Township designated to license kennels in this Township for a license entitling him to keep or operate such establishment.
- B. The application shall describe the premises where the establishment is to be located or proposed to be located and the purpose or purposes for which it is to be maintained and shall be accompanied by the written approval of the *Hunterdon County* Board of Health of said Township, showing compliance with the local and state rules and regulations governing the locale and sanitation of such establishment. *Such written approval from the Hunterdon County Board of Health shall be dated within one year of the application date.*
- C. The annual license fees for kennels and pet shops shall be as established in Chapter 83, Fees. No fee shall be charged for a shelter or pound. Said license shall expire on the 30th day of June of each year and shall be subject to revocation by the Township on recommendations of the Hunterdon County Board of Health for failing to comply with the applicable local and state rules and regulations governing the locale and sanitation of such establishment.
- D. No dog kept in a kennel, pet shop, shelter or pound shall be permitted off said premises except on a leash or in a crate or under safe control.

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 4. This Ordinance shall take effect upon final passage and publication according to law.
