# -RESOLUTION-100% Tax Exempt Veteran

Mr. Krov moved and Mr. Wilhelm seconded the motion to adopt the following Resolution:

## RESOLUTION

Authorizing the Chief Financial Officer to refund local property taxes to Fully Disabled Veteran Michael B. Chobin

**WHEREAS**, N.J.S.A. 54:4-3.30-34 grants an exemption from local property taxes for the dwelling house of a qualified totally disabled veteran; and

WHEREAS, Michael B. Chobin, a veteran, has been declared a 100 percent totally disabled veteran by the Department of Veteran's Affairs effective March 7, 2017; and

WHEREAS, Michael B. Chobin made application for exemption from taxes on April 2, 2019; and

**WHEREAS**, the Tax Assessor has determined the dwelling of Michael B. Chobin, Block 16.01 Lot 11, 27 Fawn Ridge Road, is exempt from property taxation effective January 1, 2019; and

WHEREAS, the Township has granted refunds of previously paid taxes to totally exempt veterans under certain circumstances; and

WHEREAS, the decision as to whether to reimburse totally exempt veterans for past taxes is discretionary on behalf of the Township; and

WHEREAS, the Township wishes to strike a balance between honoring veterans who have made an incredible sacrifice on behalf of their fellow countrymen against the financial burden that the return of taxes imposes upon non-exempt property owners; and

WHEREAS, the caps placed upon municipal spending by the State of New Jersey have imposed financial burdens on the Township and placed severe strains on its budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Holland, County of Hunterdon, State of New Jersey as follows:

- 1. The Township Committee believes that a fair and reasonable balance to be struck between its responsibilities to the general taxpayers and its need to recognize the sacrifices made by totally disabled veterans is accomplished by providing that totally disabled veterans will receive a refund of local property taxes from January 1st of the year the veteran submits to the Tax Assessor a fully qualifying application for exemption from local property taxes on the veteran's dwelling pursuant to N.J.S.A. 54:4-3.30-34.
- 2. In the case of Michael B. Chobin, he is declared exempt from local property taxes on his dwelling commencing January 1, 2019 and the Chief Financial Officer is authorized to refund him \$1,548.85 of local property taxes paid from January 1, 2019 and the Tax Collector forgive the remaining taxes owed for tax year 2019 in the amount of \$1,258.67 for the 2nd quarter and the taxes owed for the 3<sup>rd</sup> and 4<sup>th</sup> quarters of 2019 which are not yet certified.
- 3. The Township Committee will apply this policy to any future veterans seeking totally exempt status, but reserves the right to amend and alter it based on the future financial condition of the municipality.

# ORDINANCE 2019-8 ORDINANCE AUTHORIZING THE TOWNSHIP OF HOLLAND TO ACCEPT THE DONATION OF CERTAIN PROPERTIES FOR OPEN SPACE PURPOSES

**WHEREAS**, Tad J. Dabrowski is the owner of certain property located in the Township of Holland (the "Township") and designated as Block 22, Lots 38, 40, 53, 119, and 120 on the Tax Map of the Township of Holland (the "Property"); and

WHEREAS, Mr. Dabrowski has offered to donate said Property to the Township; and

WHEREAS, the Property is near or adjacent to open space parcels owned by the State of New Jersey; and

WHEREAS, the Township has, after consultation with its legal and engineering professionals, determined that it is in the public interest to accept such donation; and

WHEREAS, the Township desires to accept the donation of the Property subject to due diligence regarding environmental or any other issues that may affect the Township's acceptance and ownership of the Property; and

WHEREAS, N.J.S.A. 40a:12-1, et seq., the Local Lands and Buildings Law, authorizes municipalities to acquire real property by gift pursuant to a duly adopted ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Committee of the Township of Holland, the County of Hunterdon, as follows:

**SECTION 1.** The Township hereby accepts the land donation of Block 22, Lots 38, 40, 53, 119, and 120 from Tad J. Dabrowski subject to due diligence regarding environmental or any other issues that may affect the Township's acceptance and ownership of the Property.

**SECTION 2.** The Mayor and Clerk are hereby authorized to take all action necessary to effectuate the acquisition of the Property.

**SECTION 3.** All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**SECTION 5.** This Ordinance shall take effect upon final passage and publication according to law.
