#### RESOLUTION

# RESTORING THE SPEED LIMITS ON CERTAIN ROADS TEMPORARILY REDUCED DUE TO THE CONSTRUCTION PROJECT ON COUNTY RTE. 519, CONDUCTED BY HUNTERDON COUNTY

WHEREAS, the Township Engineer has certified, under his seal as a licensed professional Engineer, to the Mayor and Council that the speed limit on certain streets which were temporarily reduced in Ordinance 2019-2 and 2019-16, can be restored to their normal limits as the construction project on County Rte. 519 conducted by Hunterdon County, is substantially complete pursuant to the Memorandum of Thomas B. Mathew, Hunterdon County Engineer/Director of Public Works, dated January 9, 2020, attached hereto as Exhibit A; and

WHEREAS, original Ordinance No. 2019-2 provided for the expiration of the temporary limits upon completion of the project which shall be determined by written Engineering Certification, as well as the removal of the temporary speed limit signs; and

**WHEREAS**, original Ordinance No. 2019-16 provided for the expiration of the temporary limits upon completion of the project which shall be determined by written Engineering Certification, as well as the removal of the temporary speed limit signs; and

**WHEREAS,** a certified copy of this Resolution shall be transmitted by the Clerk of the Township of Holland, Hunterdon County, New Jersey, to the Commissioner of Transportation within 30 days of its adoption; and

WHEREAS, the Township shall be responsible for the removal of the temporary signs.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of Township of Holland, in the County of Hunterdon, and State of New Jersey, as follows:

1. The speed limits shall be restored on the following streets:

Church Road Hawks Schoolhouse Road Bellis Road Shire Road Anderson Road

- 2. The Township shall remove all temporary speed limit signs; and
- 3. This Resolution shall take immediately.

# AUTHORIZATION TO HIRE MARIA ELENA JENETTE KOZAK AS LAND USE ADMINISTRATOR

WHEREAS, the Township Committee of the Township of Holland is in need of a Land Use Administrator, and

**WHEREAS,** this position is established by <u>ORDINANCE 2020-03</u>, an Ordinance Amending Chapter 100, Article III, Entitled "TERMINOLOGY," that will be adopted on Final Reading February 4, 2020; and

WHEREAS, ORDINANCE 2020-03 defines the position of Land Use Administrator as:

A position that may be filled at the discretion of the Township Committee for a period of one year whose duties shall include the following:

- A. to serve as the secretary to the Planning Board;
- B. to serve as the secretary to the Zoning Board of Adjustment;
- C. to serve as the Zoning Officer;
- D. to serve as the Development Regulation Officer;
- E. two serve as the Municipal Housing Liaison; and
- F. to perform other duties as assigned by the Township Committee, Planning Board or the Zoning Board of Adjustment.

**WHEREAS**, the 2020 salary of \$48,000.00 for this position was established in the 2020 Salary Resolution adopted January 7, 2020; and

**WHEREAS**, this employee will be appointed for a 12 period retroactive back to January 1, 2020; and

WHEREAS, this employee will be a full time employee working 37 ½ hours/week (32 ½ hours will be office hours, open to the public, and the remainder of the hours will be satisfied remotely and performing inspections, and

**WHEREAS**, this employee will be eligible for Health and Dental Insurance according to current Township policy, and

WHEREAS, this employee is entitled to paid holidays, paid vacation and paid personal days calculated based on her initial start date of June 9, 2008; and

WHEREAS, this employee is entitled to paid sick leave calculated based on the effective date of this Resolution; and

**WHEREAS,** according to the Chief Financial Officer, there are sufficient funds available in the General Operations Municipal budget to pay for this employee; and

WHEREAS, a current copy of the Holland Township Employee Handbook will be made available to this employee for review and will be required to comply with all policies in the handbook, and

WHEREAS, this employee will be required to attend and pass all required training and certification classes; and

WHEREAS, this employee is currently employed with Holland Township and will not be required to submit to a background check required.

**THEREFORE, BE IT RESOLVED** by the Holland Township Committee, Township of Holland, County of Hunterdon in the State of New Jersey, that Maria Elena Jennette Kozak will be hired as Holland Township Land Use Administrator effective January 1, 2020.
