Authorizing the Mayor to Sign all Documents Regarding the State of New Jersey, Department of Law & Public Safety, Office of the Attorney General for Body-Worn Camera Grant Program

WHEREAS, the State of New Jersey, Department of Law & Public Safety, Office of the Attorney General (OAG) received funds from the SFY21 Budget to administer the Body-Worn Camera Grant Program, and

WHEREAS, the State of New Jersey Law and Public Safety Office of the Attorney General has given notice of availability of funds for Body-Worn Camera Grant Program, and

WHEREAS, the name of the program is SFY21 Body-Worn Camera Grant Program (BWC Grant Program), and

WHEREAS, the Body-Worn Camera Grant Program is designed to provide eligible law enforcement agencies with state funding to aid in the purchase of body-worn cameras, ancillary equipment and storage, and

WHEREAS, under the BWC Grant Program, law enforcement agencies are eligible to receive grant funding for the purchase of body-worn cameras and related expenses, and

WHEREAS, the deadline by which applications must be submitted by April 30, 2021, and

WHEREAS, the recipients of Body-Worn Camera Grant Program funding will be allotted a fixed dollar amount for each camera to be purchased. This dollar amount will exceed the cost of a camera, and

WHEREAS, the excess funding is to be used for ancillary equipment such as clips, chargers, batteries, etc., as well as storage costs, and

RESOLUTION

Opposing the Administration of President Biden's Support of PennEast Appeal of the U.S. Third Circuit Court of Appeals Decision Regarding Condemnation of State Owned Public Land

WHEREAS, in 2019, a three-judge panel of the U.S. Third Circuit Court of Appeals in Philadelphia rendered a decision determining that condemning State owned public land violates the U.S. Constitution's 11th Amendment which gives sovereign immunity to States and shields States from private lawsuits, and

WHEREAS, the PennEast Pipeline Company, having been granted eminent domain authority by the Federal Energy Regulatory Commission (FERC), allowing it to seize land from property owners, appealed the decision to the U.S. Supreme Court, in furtherance of its continued efforts to build part of its natural gas pipeline through 44 State-controlled parcels of land in New Jersey, and

WHEREAS, the Administration of President Joseph Biden, through the U.S. Justice Department, has supported the PennEast appeal in a brief to the U.S. Supreme Court, and

WHEREAS, the State of New Jersey has opposed PennEast's appeal arguing that a private party like PennEast has no right to condemn State lands, which involves more than 40 properties including public State-owned land, as well as private land with conservation easements, and

WHEREAS, the Third Circuit ruling prevents the abuse of eminent domain, which Hunterdon County's Board has long opposed, and the doctrine of sovereign immunity, which protects States' rights, and should not be overturned, and

WHEREAS, the PennEast project unnecessarily threatens property rights and offers no prospect of just compensation for the land it targets for lease or condemnation, proposes to pay owners the one-time loss of value attributed to the new encumbrance on property, and understates the value of the easement to PennEast, and

WHEREAS, the planned pipeline route disturbs a fifty-three acre well service area in Holland Township and over 2,000 acres of Hunterdon County farmland and conservation easements for which State and County taxpayers have paid millions of dollars to preserve, thereby destroying the easements.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Holland, that the Township Committee supports the decision of the U.S. Third Circuit Court of Appeals to protect sovereign immunity and calls on New Jersey's Governor Phil Murphy and U.S. Senators Bob Menendez and Cory Booker to strongly encourage the Biden Administration to change its decision to support PennEast's U.S. Supreme Court appeal, and
