# **AUTHORIZING ESTIMATED 2023 TAX BILLS**

WHEREAS, the 2023 tax levy has not been certified at this time and said levy will not be certified in time for tax bills to be mailed in a timely manner; and

WHEREAS, there will be insufficient cash flow to support municipal operations in late July, August and September unless third quarter tax revenue is received on time; and

WHEREAS, the Tax Collector and Chief Financial Officer have reviewed and computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Holland as follows:

- 1. The Tax Collector of the Township of Holland is authorized and directed to prepare and issue estimated tax bills for the third installment of 2023 taxes in accordance with the provisions of N.J.S.A. 54:4-66.2 et seq.
- 2. The estimated tax levy to be used for the preparation of the estimated tax bills shall be \$19,657,495.67 which is 2% more than the tax levy of 2022. The estimated tax rate for 2023 is 3.118.
- 3. The Tax Collector shall take whatever action as permitted and required by Chapter 72 Public Laws 1994 and N.J.S.A. 54:4-66.2 and 54:4-66.3.

# ORDINANCE 2023-09

# RESCINDING THE TOWNSHIP COMPUTERS, INTERNET, VOICE MAIL, AND EMAIL USAGE POLICY, AND ADOPTING THE HOLLAND TOWNSHIP INFORMATION TECHNOLOGY COMPUTER USAGE POLICY

**WHEREAS**, the Township of Holland is desirous to update and revise its Computer, Internet, Voice Mail and Email Usage Policy; and

WHEREAS, the Township Committee has drafted the Information Technology Computer Usage Policy and will issue the revised policy attached as Exhibit "A."

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Committee of the Township of Holland, in the County of Hunterdon, that the Holland Township Information Technology Computer Usage Policy attached hereto is hereby adopted.

**SECTION 1.** All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

**SECTION 2.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**SECTION 3.** This Ordinance shall take effect upon final passage and publication according to law.
