I. Minutes

II. Farmland Preservation Applications:

- A. Brown: Larry recently talked to Randy Brown, who indicated that their attorney continues to work with state and county attorneys regarding the estate situation.
- B. Kerr (B15 L1): Road sign indicates "under contract" on it. Probably will not be preserved in the near term.

III. Other Land Preservation:

- A. Silva Farm: B10 L43 (97.25ac) and B14 L20 (32.99ac): Larry is researching the feasibility of a nonprofit purchasing the property, preserving it, and then reselling it. Green Acres?

V. Other Business

The reorganization meeting is January 5, 2017. Meeting dates will be sent out soon.

Banking 2016 county open space funds: Committee agreed that the Township will 'bank' its share of these funds, which will be used for farmland preservation and the continued restoration of the historic Riegel Ridge Community Center. Our current balance is \$59,771.93.

Township write its own option agreement for farmland preservation applications: At the last monthly County Ag meeting, we discussed whether the Township could write its own option agreement with a figure lower than the \$7000/acre county default. Both the county and state staff didn't see any reason why we couldn't.

VI. Correspondence

FSA letter received regarding Block 6 Lot 49: No action required by Holland Township

Letter from FERC regarding route modifications: This letter, dated Nov 4, 2016, was sent because a township property has been identified as potentially being affected by the path of a route modification and requests the township's comments. Deviation #1710 on gravel hill touches Block 22 Lot 90, which is owned by the township.

Letter regarding Environmental Review Schedule received: Environmental Impact Statement (EIS) issuance date Dec. 16. Final (EIS) due Feb 17, 2017. (90 day) Federal authorization decision deadline May 18, 2017.

VI. Pipeline Update:

The township received a letter from PennEast, dated November 28, 2016, with a non-disclosure agreement attached. In it, PennEast agrees to allow the township to be a consulting party based on a letter previously sent by our attorney dated September 9, 2016.
